# Re: Sakugoro FUKUYAMA, Reg. No. 00592

This man signed a declaration to the Custodian on March 27, 1942. He was evacuated on April 4, 1942.

In his declaration he reported 3 boxes, a trunk and personal effects, tools, etc. left at Bowen Island. These were shipped to him in January, 1946.

He reported a balance of \$509.73 with the Japan & Canada Trust Savings Co. As this man's name does not appear on the list of depositors of the Company as at December 21, 1942, we assume this money was withdrawn prior to that date.

He reported a bank account with a balance of \$200.00 in the Bank of Montreal, Vancouver. He reported a \$2,500.00 policy with the Canadian Mutual Benefit Association. These items did not come under the control of this office.

He reported a debt owing to him by Kinzo FUJIOKA. On May 6, 1944, he inform us that FUJIOKA had died and as we had no funds standing to FUJIOKA's credit nothing further was done by this office.

The Mix Gold Mines, Ltd. informed this office in August, 1945, that this man was a policyholder in that company but that the shares were of little value. This did not come under the control of this office.
