April 20, 1943 Mr. Spain reported that Mr. Wills had been told by the owner of the premises that nothing had been there when she took over the place.

Mrs. Kichijiro Hagane, Sept. 3/42, reported ownership of no property, so presume that she disposed of goods before she was evacuated.

November 2, 1944 at auction were sold shades & dishes to value of \$3.20. Net credit of \$2.33 was placed in account of Hagane. File does not show where these goods came from or why they were considered the property of this man. Funds have been remitted to Hagane.

The cash surrender value of Monarch Life policy of Mr. & Mrs. Kichijiro Hagane was received and credited to the account of Kichijiro Hagane at his wife's request. The funds from this source - \$179.15 have been remitted to Kichijiro Hagane.

No liabilities were reported on this file.

MEMORANDUM

To: Mr. Wilson
From: Mr. Spain

Re: Safety Garage

During an inspection of the basement at 514 Alexander Street, we discovered what appears to be a considerable quantity of garage equipment.

The basement is so heavily congested with an accumulation of articles, that it will be impossible to make an inventory here. I would suggest that everything belonging to Japanese in this building be moved to warehouse, as the present location is very unsatisfactory from a protection point of view.

The names of other Japanese were noted here, as follows and I have given File Numbers wherever they have been ascertainable:

If the garage equipment has any value, it would seem to be our duty to sell it for the benefit of creditors in File 11044.

When everything is removed from this basement we will probably uncover the names of innumerable Japanese.

Referring to your letter of August 5th and further to our telephone conversation of yesterday's date. On June 15th you wrote us asking for instructions in connection with an application for surrender of the above numbered policy. On June 26th we advised you that we had referred the matter to your policyholder, Mr. HAGANE, to ascertain his wishes in connection with disposition of proceeds of the policy. On June 30th we received word through the Internment Camp that the policy for which Cash Surrender had been applied was a policy in the name of his son, Toshio HAGANE.

In referring to Toshio HAGANE'S File (Internee 462) we find that his Policy No. P111,360 has been cashed in and a cheque amounting to \$61.90 sent to this office in your letter of July 3rd.

According to advice from your office both written and verbal, there seems no doubt that Mr. Kichijiro HAGANE and his wife are applying for surrender of the above numbered policy jointly covering their two lives. Under these circumstances I suggest and advise you to proceed with the surrender of this policy No. P97149, sending the cheque to cover the Cash Surrender Value to this office.
