This woman signed a declaration to the Custodian on March 24, 1942. She was evacuated on June 22, 1942.

In her declaration she reported 9 pieces of effects stored at S Sunnyside Cannery. These were all shipped to her on May 29, 1942.

On November 24, 1942 we received a request for shipment of 3 more pieces of effects. These could not be located and as they were not declared no further action was taken by this office.

This file reveals no other property of any kind.

This summary is certified to be in accordance with information on file.

On August 29, 1946, the account of Tsune IMAI was credited with the sum of \$53.40, being proceeds of the redemption of War Savings Certificates registered in the name of her late husband, Matsutaro IMAI, File 15335. These funds were remitted to Mrs. Tsune IMAI on September 3, 1946.

On December 7, 1946, this office received from the Royal Bank of Canada, Prince Rupert, the sum of \$98.82. This was the bank balance in the savings account of the late Matsutaro IMAI. These funds have been credited to the account of Tsune IMAI.
