The bank sent to this office the sum of \$96.82, which was the amount to the greatt of the account of the late Material IMAL. These funds are now greatted to the account of Mrs. Texno IMAL, File 462, widow of Materials IMAL and nother of sukero that Apart from the bank balance, the only assets of the late Matsutaro IMAI of which this office has any record were the War Savings Certificates which his widow turned in for redemption. The sum of \$53.40, being redemption value of the Certificates, was received in this office on June 24, 1946. This money was remitted to Mrs. Tsume IMAI on September 3, 1946. It was thought at that time that these funds comorised the entire estate of Metsutaco that Deceased
