On May 14, 1942 this trunk and 2 boxes of kitchen utensils were shipped to Vancouver and handed to this man's wife, File No. 1796. He reported a \$50.00 Victory Bond in the Royal Bank of Canada and a bank account with a balance of about \$700.00 in the Royal Bank of Canada. Kitchen stove, bed and 6 chairs were sold as Mr. Sugimoto requested me to so before leaving.

According to our records, Kenichi Moriyama was paid by Ch #679, March 21st \$39.06. I am writing to the town office to find out whether this checue has come through the bank or not; if you were to call by telephone Kerr. 3233, they will tell you if this checue has come through yet or not.

I am enclosing a list of all the goods or articles shipped by the U. S. S. Co. belonging to Japanese.
