LIFE INSURANCE:

No property of any kind whatsoever was declared to the Custodian by the above Japanese person when registering (J Card) on April 4, 1942. However, in a statement of assets and liabilities completed by K. Matsumoto under date of May 15, 1942, at Petaunua Internment Camp, he stated he had a \$1000 Monarch Life Assurance Policy. On making enquiries the Monarch Life Assurance Company advised the Custodian that the above policy was issued in May 1941 with an annual premium of \$45.85, policy number being #116,103, and that the policy lapsed when the 1942 premium was not provided for and was definitely terminated by their Company (Ref. - Monarch Life Assurance Co. letter of Apr.15/44).

Accordingly, we are now forwarding to Mr. Matsumoto his Monarch Life Assurance Policy No. F116,103. (Custodian Letter Aug.26/48).
