In her declaration she reported a trunk left at Wilson Creek, B.C. On June 4, 1942, the husband of this woman, File No. 1415, applied for this trunk along with his chattels and lacking evidence to the contrary we assume that it was shipped.

She reported personal effects in her own possession at Hastings Park. We assume she took these with her on her evacuation.

She reported a bank account with a balance of \$100.00 in the Bank of Montreal, Vancouver. This did not come under the control of this office.

This file reveals no other property of any kind.
