On June 30, 1942, the above noted Internee declared to the Custodian that he left certain fishing boat equipment at 1228 Stewart Avenue, Nanaimo, B. C., at which address he resided before internment.

The property known as 1228 Stewart Avenue, Nanaimo, was owned by the Internee's father, Masajiro SHIN, Evacuee File 1404, and all goods stored on the premises were held under the father's name. The Internee was advised of this arrangement in our letter of May 15th, 1943, and was, apparently, satisfied to have his effects dealt with in this manner.

Disposition of chattels found on these premises have therefore been dealt with under Evacuee File No. 1404.

No property interests, other than the above mentioned, appear on this file.
