PERSONAL PROPERTY SUMMARY

April 25, 1946.

Re: Doi (Mrs. Torao) TAKEDA, Reg. No. 07440

This woman signed a declaration to the Custodian on April 4, 1942. She was evacuated on September 8, 1942.

In her declaration she reported a quantity of household effects, foodstuffs and carpenter tools stored at Port Alberni. These were apparently numbered 1 to 15. 11 pieces were shipped on May 20, 1942, and 4 pieces were shipped in December, 1942. The carpenter's tools declared by Mrs. TAKEDA, were not among the 15 pieces and we have no record of them.

In her declaration this woman declared a \$1,000.00 life insurance policy with the Monarch Life Assurance Co. This did not come under the control of this office.

This file reveals no other property of any kind.

This summary is certified to be in accordance with information on file.
