On August 18, 1944, the R.C.M.P. notified us that HIKIDIA had surrendered a Jiffy Kodak Camera, which was turned over to the Custodian on August 16, 1944. This camera is in the Custodian warehouse. This file reveals no other property of any kind. This summary is certified to be in accordance with information on file. 4 macheson April 6, 1946.
