PERSONAL PROPERTY SUMMARY

RE: Eichi KONDO, Reg. No. 01796

CHATELS:

The above, on his declaration dated April 4th, 1942, declared gardener's tools left with his sister, Mrs. KOBAYASHI, at 1700 Pine Street, Vancouver. The file reveals that repeated efforts were made to get in touch with the occupant of this address in an endeavour to get the tools Mr. KONDO stated had been left there. Finally, our representative, Mr. D.A. Smith, succeeded in contacting the tenant, Mrs. A.N. Clark, who advised him that no chattels of any kind had been left on the premises by Mr. KONDO. We wrote to Mr. KONDO on November 4th, 1943, and gave him this information, telling him that unless we heard from him to the contrary, we would assume that he had made his own arrangements for their disposal before his evacuation. No reply was received to this letter.

BANK
ACCOUNT:

Eichi KONDO declared a bank account in the Royal Bank of Canada, 7th Ave. & Granville Street, in the amount of \$120.00. This did not come under the control of the Custodian.

INSURANCE:

Although Mr. KONDO did not declare any life insurance, we were advised by the Sun Life Assurance Co. that he had a policy No. 2217107 with them in the amount of \$1000.00. Even though he was unable to pay the premium due on this account, the policy was held in suspense since he was at that time an Internee at the Angler Internment Camp. He was released from internment on July 6th, 1943. We then wrote to the Sun Life Assurance Co. and advised them of this fact and stated that we now had no further interest in his insurance policy.

No property interests other than those mentioned above are found on this file.

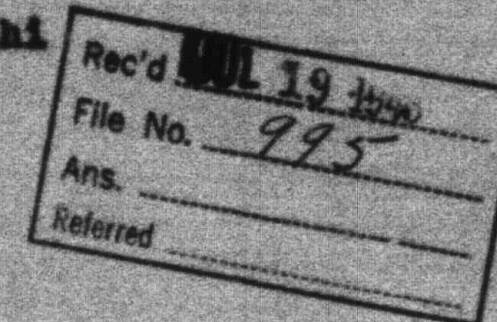
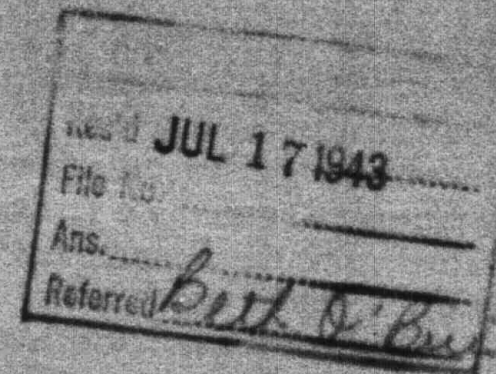
