GENERAL SUMMARY

Re: Marukitaru HAYASHI - Reg. No. 07497

Prior to his evacuation on Sept. 23, 1942, this man was employed as a millhand by Bladdel Stewart Co., Port Alberni, B. C. and lived in a bunkhouse there, paying \$20.00 per month for rent and board.

Chattels

In his declaration to the Custodian March 20, 1942, HAYASHI reported owning no chattels. However, an inventory from 992 Powell St. had listed in the name of Mrs. M. HAYASHI the following items:

- (1) Stove (Grated)
- (2) Caston Stove Pipes

These articles were moved from 268 Powell St. to the Custodian Safe Warehouse, and on Dec. 1, 1942 a letter was written to Mr. HAYASHI inquiring if these chattels were his property. Reply was received on same letter, (according to notation on our copy of same date) stating that they do not belong to him, and that he did not live at this address in Vancouver. *Inventory #228 moved to file # 6597 - 1/19/47 M.G.*

Bonds

In his declaration, HAYASHI reported the following:

- (1) One \$50.00 Victory Bond, in his possession.
- (2) Fifteen \$4.00 War Savings Certificates, Also in his possession.

Neither of these articles came under the control of the Custodian.
