One annual premium of ¥42.65 (\$21.55) was paid. However, the Insured failed to pay the premium due the following year, and the policy therefore lapsed.

Policy No. 559,279 is no longer in force. It was surrendered for its cash value in May, 1942, when a cheque for \$264.54 was issued.

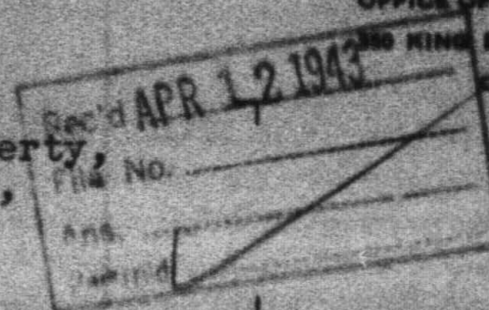
