

Re: Tsui (Mrs. Tasajiro) SHIKATANI, Reg. No. 08019

This woman signed a declaration to the Custodian on April 4, 1942. She was evacuated from the protected area on November 16, 1942.

In her declaration she reported 1 sewing machine and 1 trunk left with Frank Beban, Northfield, B.C. On September 18, 1942, Mr. Beban informed this office that the sewing machine and trunk had been shipped to Mrs. SHIKATANI some time before that date.

She declared War Savings Certificates and a Manufacturers Life Co. insurance policy No. 808719 for \$1,000.00. Neither of these items came under the control of this office.

This file reveals no other property. Most of the chattels owned by this woman and her husband are dealt with in the file of her husband, file 2386.

This summary is certified to be in accordance with information on file.
