

GENERAL SUMMARY

August 13, 1946.

Re: Hiroshi HAMASAKI, Reg. No. 10526

This man signed a declaration to the Custodian on March 24, 1942. He was evacuated on March 25, 1942.

In his declaration he reported a \$5.00 War Savings Certificate and a \$10.00 War Savings Certificate, both in his own possession. These did not come under the control of this office.

The R.C.M.P. handed to this office two Kodak Brownie cameras which had been surrendered by this man. These were shipped to him in September, 1944, as he remitted to this office \$1.00 to cover mailing costs and the receipt given to him at the time the cameras were surrendered.
