This man signed a declaration to the Custodian on March 23, 1942, the day of his evacuation.

In his declaration he reported 12 pieces of household goods, grocieries, etc. stored at the Japanese Hall, Port Alice, B.C. These were shipped to him at Hastings Park in May, 1942 and we assume forwarded to him at Tashme.

In his declaration he reported a \$100.00 Victory Bond and \$40.00 in War Saving Certificates in his wife's possession. He reported a bank account in the Royal Bank of Canada, Vancouver, with a balance of \$300.00. These items did not come under the control of this office.

He reported a 25-year endowment policy with the Sun Life Assoc. Co. for \$1,000.00 and a life insurance policy on his son for \$1,000.00 with the Sun Life Assoc. Co., and a life insurance policy on another son for \$1,000.00 with the Mutual Life Assoce. Co. These policies did not come under the control of this office.

This file reveals no other property of any kind.
