GENERAL SUMMARY

Re: Monosuke KAWAMURA Reg. No. 10224

This man was a logger, employed at Suzuki Camp, Stillwater, B. C. before his evacuation. He signed a declaration to the Custodian at Hastings Park on March 19, 1942, after his removal from Stillwater. He was evacuated from the protected area on March 21, 1942. The persons removed from Stillwater, according to information supplied to this office (See File A/76) were not given much time to prepare for their removal. As a result men working in the woods are reported to have left their tools in the bush. Other goods were left at the camps.

KAWAMURA reported ownership of no real property and none is revealed in his file.

KAWAMURA reported ownership of the following tools and other goods:

In Shed at Suzuki Camp:

Royal Saw 7 feet, 5 inches -	\$16.50	} No saws were inventoried by Logan at this camp in June, 1942.

Shingle Bolts cut and not paid for - 55 cords at \$2.00 - \$110.00. This was a claim against the Suzuki Company. Suzuki appears to have been a sub-contractor under M. Ehisuzaki Company who had the contract for shingle bolts. A claim for \$30.91 wages due KAWAMURA from M. Ehisuzaki Company was filed by Suzuki. This claim was paid in full, and the funds are being credited to the account of KAWAMURA today. The difference between the amount reported by KAWAMURA and the amount claimed on his behalf by Suzuki is not explained in our records, but this may be due to some advances made by the company to KAWAMURA. It may also be due to an overvaluation of the shingle bolts.
