I received your letter on the 29 of April and I wish to say that I'm sorry but it was not the 12 refund but a refund from the Dominion Income Tax after the 19% wage deduction ceased.

I started to work for ⁽¹⁹⁴¹⁾ about the 1st of August and ceased work on March 18, ⁽¹⁹⁴²⁾ and when I made out my Dominion Income Tax I did not have to forward some money to the Dominion Gov. like the others but had a refund of approximately \$23.
