Mrs. Yoshikumi was contacted and advised that these bonds had been sold and proceeds used for medicine and personal expenses of the Internee. Kazuo Yoshikumi confirmed this.

Hight \$5.00 War Savings Certificates were held in safe-keeping at this Office and were redeemed for \$35.48 prior to Yoshikuni's departure for Japan.

\$137.60 was forwarded to this Office by the Royal Bank, Cumberland, B.C. and credited to the Internee's account with the Custodian.
