

LIABILITY SUMMARY

Re: KANASHIRO, Taro - Reg. No. 04311.

Two claims appear on this file:

1 - Kameya Co. - Jichiro MORIMOTO - \$31.45

2 - Dr. J. A. Smith - \$150.00

This second claim is against Kentoku KANASHIRO, File 12190, minor son of Taro. Both claims were submitted to Taro. On February 10, 1944, Kentoku, on behalf of his father wrote as follows: "We are not able to make any payment at present."

Both creditors were advised on February 22, 1944 and given KANASHIRO's address. KANASHIRO was also advised on the same day that we presumed the claims were correct and that we had advised his creditors.

PERSONAL PROPERTY SUMMARY

Re: KANASHIRO, Taro - Reg. No. 04311

The above signed a declaration to the Custodian on March 14, 1942 and was evacuated on March 15, 1942.

He declared that he was a retired Shingle Mill worker, formerly employed with the Sterling Lumber Co. He resided at 507 Hawkes Avenue where he paid a monthly rental of \$15.00. The landlord's name he stated that he thought it was the Canada Permanent Trust Co.

CHATELS: He declared the contents of a 6 roomed house including Wood coal stove, Pedal Sewing Machine. On October 20, 1942 we wrote to him that we had called at 507 Hawkes Avenue and that we had been advised that he had sold or otherwise disposed of his chattels. As was customary we sent him a copy of the letter and asked him to confirm our surmises by signing it and returning it to us. He did so.

It has been found that often the Japanese signed lists of chattels or copies of letters and later gave us contrary information. However as KANASHIRO has never enquired about his chattels or requested the shipment of any, it is presumed that he had disposed of his chattels before evacuation.

This file reveals no other property of any kind.
