We are in receipt of your letter dated December 22, 1947, requesting information of the disposition of your household chattels. Enclosed herewith are Custodian auction sheets covering the sale of goods identified as yours. The funds derived from the sale of these articles have been remitted to you, the final balance in your account being forwarded by this office to you on November 28th, 1947.

In your letter of December 22nd, you also request that this office send you "a .22 rifle, a 12 repeater shotgun." These did not come under the control of the Custodian, they were handled by the Royal Canadian Mounted Police.
