GENERAL SUMMARY

File 738

August 7, 1946.

Re: Chitagoro IWABUCHI #09378

This man signed a declaration to the Custodian on March 24, 1942. He was evacuated on June 22, 1942.

In his declaration he reported ownership of 1 Spring Gill-net 4/50 Barbour Twine, value \$155.00; 1 Sockeye web value \$75.00; 1 Cohoe Net, value \$35.00, all stored in the B. C. Packers Net house, Port Essington. No funds have been paid to the Custodian from the sale of these nets. There have been no inquiries from IWABUCHI in regard to these nets. According to information received from Sunnyside Cannery (where these nets probably were left) there is nothing of value remaining there belonging to Japanese. Custodian agent at Port Essington made no report in regard to these nets. It is assumed therefore that IWABUCHI, like many other fishermen, disposed of his nets prior to his evacuation.

He reported a fishing vessel. This appears to be the vessel sold by IWABUCHI on April 6, 1942, through the Japanese Fishing Vessels Disposal Committee. The net proceeds of this sale, \$96.50, were paid to him on April 21, 1942.

The sum of \$5.00 was credited to the account of Chitagoro IWABUCHI in full settlement of claim lodged with the Japanese Fishing Vessels Disposal Committee for refund of expenses incurred at the impounding of his vessel.

IWABUCHI reported a \$50.00 Victory Bond. This did not come under the control of this office.






