All charges for freight and storage to be paid by the consignee.

On September 18, 1942, this office wrote to ISHIDA stating that it was understood that he had taken with him all his personal chattels, and asking him to confirm this. As no reply is on file, and apparently none was received, the matter was regarded as closed.
