GENERAL SUMMARY

This man signed a declaration to the Custodian on March 19, 1942. He was evacuated on March 21, 1942.

Prior to his evacuation, INOUYE was employed as a logger by Robert McMair Shingle Company (Taire Camp) Stillwater, B. U.

CHATTELS

INCUTE reported a list of logging equipment left at Stillwater Camp and in the bush. The evacuation from Stillwater was very sudden and the Japanese had no time to arrange for the storage or shipment of their goods. Mr. Green's memo of April 30, 1943, states that it was impossible to identify ownership of the tools found in the camps and that there were tools in the bush which could only be found by the Japanese themselves, for that reason, few or no Stillwater chattels have been accounted for. Nothing further can be done in regard to INOUYE's equipment unless he should claim for loss.

MONTES OWING

INOUTE reported the sum of \$232.00 owing him for cutting shingle bolts (li6 cords) by M. EBISUZAKI Go. However, the Statement received from P. S. Hoss & Sons in regard to M. EBISUZAKI Go. and Taira Camp shows that \$210.00 was credited to INOUTE and his son George INOUTE, File 2346, for 100 cords shingle bolts at \$2.10 per cord. From this amount, board charges for INOUTE and his son, amounting to \$225.47, were deducted, leaving a balance of \$15.44 owing M. EBISUZAKI by the two men. There are no funds in either account with which to settle this debt.

LIABILITIES

The sum of \$15.44 is owing M. EBISUZAKI Co. by INOUYE and his son for unpaid board. (See Menies Owing)

It would cost more than the value of these tools to take them away."
