He reported a \$2,000.00 life insurance policy with the Manufacturers Life Insurance Co. This did not come under the control of this office.

R.C.M.P. information reported that this man was the owner of a motorcycle. There is no record of a motorcycle belonging to this man having been surrendered to the R.C.M.P. and Mrs. NIYA did not declare ownership of a motor-cycle.
