Dear Sire We have for acknowledgment your letter of the 21st of January, and note that your father, Chunel IKEDA, is unable to reply to correspondence. With regard to the sale of your father's chattels, we have referred your letter to the department responsible and they will reply to you in due course. You refer in your letter to a claim which your father has against K. YUKUTA and an AIHARA. We have a note of these in your father's file, but neither you nor he has supplied us with the full names of your debtors. Where did they live previous to evacuation? And what were their occupations? 
