Re: Hideo MATSUMIYA, Deceased.

As you appear to be the only relative of Hideo MATSUMIYA living in Canada, the sum of \$4.96, being the total funds to his credit in this office, is today being transferred to an account in your name. This sum represents a refund of 1% Wage Deduction received from the Provincial Government.

In his Custodian Declaration, your brother stated that he had \$30.00 in War Savings Certificates in his possession and an account in the Royal Bank of Canada, Vancouver.
