This file reveals that MORISADA owned no real property in any protected area of B.C. and did not carry any Fire Insurance.

CHATTELS:

MORISADA made his declaration to the Custodian on March 27/42 and was interned on May 29/42. He declared furniture and equipment for a 3 roomed house at 605 E. Gordova St. In his letter of July 30/42 sent by the Camp Commandant, MORISADA advised that he wished this furniture, etc to be left with his wife. We wrote to her regarding same and she stated in letter received from Supervisor at Slocan on Jan. 25/44 that most of the furniture had been destroyed in a fire hat partly burned down the house on July 1/42. She said she had a few dishes and 4 or 5 pictures left at the home of Mr. K. MATSUMOTO, 501 Powell St. and 1 round table stored in the apanese Buddhist Temple, corner of Cordova and Princess Ave. His wife declared nothing, so I am putting a note of this on her file.

MONEYS His account was credited with the sum of \$1.70, being cash balance RECEIVABLE: forwarded from the internment Camp.

BANK
His account was credited with the sum of \$ .77, being the balance of his account with the Bank of Montreal, Main and Mastings Sts.

No property interests other than those mentioned above are found on this file.
