GENERAL SUMMARY

File No. 880

17th July, 1946.

Re: Toshinasa MAKINO - Reg. No. 13148

The only asset declared by the above Japanese was a \$5.00 War Savings Certificate. This was not brought under control by the Custodian.

He declared he owed Y. FUJINARA \$100.00. In answer to our letter of the 30th Sept. 1942, asking for more particulars of this debt, he stated that he was not in a position to pay the amount owing and had written to Mr. FUJINARA arranging to make settlement direct. As Mr. FUJINARA made no claim for this amount, the Custodian took no further action.

A claim was filed against MAKINO at this office by Yoshiichi SHIN FOR \$40.00. MAKINO disputed the claim and asked for a statement. SHIN's statement when received showed the account to be \$32.83. No reply was received from MAKINO to our further letters about this account, and SHIN was notified that the Custodian would take no further action, and that he would have to make collection direct.

This file requires no further administration and may now be closed.
