The above in his declaration to the Custodian, dated April 3rd, 1942, declared a bicycle left at 84 Moncton Street, Steveston. In reply to our letter asking him about this article, he advised us on October 15th, 1945, that he had taken the bicycle with him at the time of his evacuation.

LIFE INSURANCE:

He also declared a life insurance policy with the Confederation Life Association, Policy No. X558039, in the sum of \$1000.00, the beneficiary being his father, Tanejiro HIROSE. This policy remained in the possession of the declarant and did not come under the control of the Custodian.

No property interests other than those mentioned above are found on this file.

We enclose herewith a letter addressed to Mr. Hirozo Hirose of Taber, Alberta, in reply to his request for the cash surrender value of policy 558 039. This policy was issued on November 7th, 1941, for \$1000.00 on the 25 Year Endowment Plan. The annual premium is \$37.04. According to our calculation the cash surrender value as at November 7th, 1945, will be \$86.00 plus a dividend of \$1.10.
