GENERAL SUMMARY

Bunsoku NISHIMURA, Dec'd.

Bunsoku Nishimura died at Sinclair Mills on January 9, 1945. According to information available, he was a widower and had no children. The only relative shown on his R.C.M.P. report is his mother, Nao, in Japan.

The deceased, in his Custodian declaration, stated that he owned logging tools at Stillwater, B. C., an insurance policy in the sum of \$2500.00 with the Mutual Benefit Association, and that the Ebesuzaki Company owed him the sum of \$43.85.

Due to the inaccessibility of the logging equipment it had to be abandoned. The account of the Ebesuzaki Company was confirmed by P. S. Ross and Sons, Liquidators, but, according to a memorandum on file dated October 25, 1945, they advised that it was improbable that anything would be realized on this claim. The sum of \$28.64 was transferred to the account of Bunsoku Nishimura from the Japan and Canada Trust Savings Company, being the balance of his account with that Company. These funds were forwarded to him on May 4, 1944. On August 10, 1945, a cheque was received from the B. C. Mutual Benefit Association for the sum of \$2500.00, covering claim under Membership Certificate #A-11,053 on the life of Bunsoku Nishimura, payable to Miss. Kayano Takehara, the beneficiary under the policy. These funds were forwarded to her on August 17, 1945.
