This woman signed a declaration to the Custodian on April 3, 1942. She was evacuated on May 2, 1942.

In her declaration she reported a sewing machine in storage at C.P.R. Wharf, Vancouver. The file of this woman's husband, File 1570, shows that this sewing machine was released on March 25, 1943.

She reported an empty bureau left at Ucluellet. File 1570, shows that this bureau was sold on July 25, 1944, at Ucluellet and the net proceeds of the sale credited to the account of this woman's husband.

This file reveals no other property of any kind.
