Re: Hideo SHIKATANI, Registration No. 08018

This man signed a declaration to the Custodian on March 21, 1942. He was evacuated on June 16, 1942.

In his declaration he reported four \$5.00 War Saving Certificates surrendered to the Custodian. These were returned to him on July 2, 1942.

In his declaration he reported a \$1,000.00 life insurance policy with the Manufacturers Life Insurance Co., the policy surrendered to the Custodian. This was returned to him on July 2, 1943.

A Power of Attorney, found with the life insurance papers, was sent to SHIKATANI who informed us this did not belong to him and we requested he forward it to his father.

A receipt for \$1,000.00 deposited in the Japan and Canada Trust Co. was also found with his insurance papers. We referred this to SHIKATANI, who informed us this did not belong to him and we requested he forward information to his mother. The Japan and Canada Trust Co. had no record of this deposit.

The account of this man was credited with the sum of \$5.08 received as refund of 1% wage deduction for 1941. This was remitted to him on July 2, 1943.
