Momotaro ICHINO declared on his original declaration of April 3, 1942 that he had one \$10.00 War Saving Certificate.

In the Royal Bank of Canada, Steveston, he had \$250.00 in a bank account.

In the safety box of his brother, Kenzo ICHING, Momotaro had a Sun Life Assurance Co. twenty-year endowment policy for \$1,000.00 with his father, Kosaburo ICHINO, as beneficiary.

The above items did not come under the control of the Custodian at that time and no action was taken by this office.

On a signed note attached to the Declaration, the following information was obtained after the Declaration had been signed. Momotaro had previously denied that any money was owing to him. However, later he stated that \$1,300.00 was owing to him from Rae Pendergast, 1300 block Hudson near 64th; father lives at 8289 Montcalm. This being the amount of a note, terms indefinite, representing the full amount of the sale of the Dedge, 1942, car to Rae Pendergast on March 3, 1942. Momotaro ICHINO was written to by the Custodian on July 13, 1944 to let the Custodian know if this debt had been settled in order to allow us to close his file. The Custodian received no reply to their letter and therefore had taken no further action.
