The above named Japanese declared on his JF Form, signed 23rd March, 1942, that he had no personal or trade debts.

However, a claim dated December 31st, 1941, was filed by Miss Hatsuyo SHINO, File 10152, in the amount of \$8.38. He wrote to NISHIZAKI asking for confirmation of this claim but received no reply. Therefore, after considerable correspondence re this claim we wrote to Miss Hatsuyo SHINO, on April 22nd, 1944, stating that this office would take no further action in this matter and suggested that she contact Mr. NISHIZAKI direct.
