### Ret Tolentro TOWATA, Reg. No. 01751

This man signed a declaration to the Custodian on March 28, 1942. He was intermed on July 4, 1942. The file does not give the date of his release.

### CHATTELS.

TOWATA declared a large quantity of household furniture and garden tools left at 823; Prior Street, Vancouver. The building at this address was found to be the property of Morio DMADA, File No. 11071, and was a very old frame rooming house containing twelve suites. As there is no further reference to chattels on TOWATA's file, the files of DMADA, Mrs. TOWATA, and the two TOWATA children have been examined but no information regarding the removal, sale, or other disposition of the goods has been found.

The Agreement of Lease, dated June 27, 1942, on the file of IMADA reveals that the building was leased by him to Mr. F. N. Hamilton, but no mention of the furniture or fixtures in the building is made. IMADA declared no chattels and his file reveals none.

A'No Property Card was signed by Mrs. TOWATA on July 4, 1942. As a considerable time had elapsed between Mr. TOWATA's declaration and hers, it is possible that the goods were disposed of prior to his internment and her evacuation. No enquiries regarding their chattels has been received from either Mr. or Mrs. TOWATA. From this, it would appear that the goods declared did not come into the hands of the Custodian but were disposed of privately by the Japanese.

### LIFE INSURANCE

TOWATA reported a \$1,000.00 Policy with the Sun Life Assurance Company. On August 24, 1942, the Policy was received from the Internment Camp. A Form D was filed by the Assurance Company in September, 1942.

A premium notice in the amount of \$22.58 was received at this office, but in letter of October 1, 1942, TOWATA advised us that he was unable to pay the premium and wished to leave it as an automatic loan. In enswer to our enquiry, the Sun Life Assurance Company notified us that the arrears in premium at October 15, 1942, amounted to \$400.15. This information was given to TOWATA in letter of October 16, 1942.

The Sum Life advised us on April 19, 1943, that the Policy had matured and the sum of \$596.07 was avalable on their receipt of the Contract of Policy and Statement of Existence of the holder. These documents were forwarded to the Company and on May 4, 1943, a cheque for \$596.07 was received to credit to TOWATA's account. A Form A was filed by the Company in December, 1943.
