

Your letter of April 25 received.

The goods which you mention are here stored in a shack on a float belonging to Ichikawa Ishinosuke.

I was given orders to sell if possible at the sum you mention \$250.00, or keep it until their return, but as the price is far too much I know it won't be sold, however at present it is no task to look after these things and it would be quite a job to pack and ship them as no boat calls here now and my boat is very small to freight heavy articles any distance. But when this camp starts in operation again the boat will call and it would be much easier then if you should wish them shipped. I do not know of any other effects left by evacuated Japanese. The rest of the camp belongs to Mrs. Tahabashi as far as I know, with the exception of my house and shingle mill which is all tied up in a bay seven miles in Call Creek.

Trusting this is satisfactory.
