GENERAL SUMMARY

The name of this man appears on the list of persons who have applied for repatriation to Japan.

In the Custodian's Safety Deposit Box are 3 War Savings Certificates valued at \$5.00 each, which were apparently surrendered by this man at the time of his declaration to the Custodian. The serial numbers of these certificates are given on list filed directly behind this summary. These are in the name of Simon NISHIMOTO.

In his declaration to the Custodian, March 21st, 1942, two days before his evacuation from the Protected Area, this man reported two trunks containing books, silver plate and shoes, left in the house of Tokichi TAKEUCHI, 316 Powell Street.

The file of Tokichi TAKEUCHI, File 6638, a former Proprietor of the Housing House at 316 Powell Street, reveals no trunks among the chattels found in these premises. It must be assumed, therefore, that these trunks were taken away by NISHIMOTO at the time of his evacuation.

This file reveals no other property of any kind whatsoever.

Dear Sir:

Your file with this office shows that the Custodian is holding five War Savings Certificates of \$5.00 value, made out in the name of Simon NISHIMOTO. These were handed by you to the Custodian. Would you kindly let us know who Simon NISHIMOTO is and where he is living at the present time?

In your declaration to the Custodian, March 21, 1942, you stated that you had left two trunks containing books, silver plate and shoes, at 316 Powell Street. No trunks were found in these premises, and it is assumed that these were removed by you prior to your evacuation.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian and, in order that you may confirm this, we enclose a stamped, addressed envelope for your convenience in replying.
