GENERAL SUMMARY

Re: ADACHI, Yaveko - Reg. No. 06573.

The above signed a declaration to the Custodian on April 2, 1942 and was evacuated on April 28, 1942.

She declared that she was unemployed and lived at Blodel with her parents.

She declared a \$50.00 Victory bond in her possession. This was not brought under the control of the Custodian.

She also declared an account, #565 with the Japan & Canada Trust Savings Co. Vancouver, B.C. in the amount of \$5.00. This account does not appear on the list given to us by the Japan & Canada Trust Savings Co. It is presumed therefore that she withdrew the balance before evacuation.

This file reveals no other property of any kind.
