MEMORANDUM

Re: Vessel "Janice" License No. 432, Prince Rupert, BR 0402

The above-named vessel was declared on JP form of Tsuneji NAKAMOTO, Reg. #10415, File No. 1134.

This vessel is licensed in name of Kazuo NAKAMOTO (probably Reg. No. 11432, File No. 1132, brother of Tsuneji)

Nelson Bros. Fisheries Ltd. state they purchased the vessel by cheque for \$500.00 on April 15 (no year) The cheque was endorsed by T. Nakamoto and Y. Nakada.

Collector of Customs, Prince Rupert, reports that the boat is now licensed (No. 1826) in name of Nelson Bros. Fisheries Ltd.; bill of sale from Kazuo NAKAMOTO. Authority for the transfer of ownership given by Const. Piper of the R.C.M.P. under date of February 23, 1942.

Unless we receive a reply from Tsuneji NAKAMOTO stating that he has not sold this boat, the matter can be considered closed.

Incidentally, the two Nakamoto brothers, according to information from the RCMP were born on February 15, 1915 and June 6, 1915, which seems some sort of a record for one set of parents.
