The above signed a declaration to the Custodian on April 3, 1942 and was evacuated on June 2, 1942.

CHATTELS: He declared personal effects in his own possession. These evidently were never brought under the control of the Custodian.

The file reveals, however, that G. H. Cottrell Ltd. were holding a trunk, 4 boxes and some machine parts (9 cases). The trunk and 4 boxes were shipped sometimen in 1943; the 9 cases were moved and sold by suction in November 1946, realising the sum of \$16.75, net.

BONDS: HAYASHI declared \$30.00 War Savings Certificates in his own possession. These were not brought under the control of the Custodian.

This file reveals no other property.


