GENERAL SUMMARY

File No. 1214

Re: Ryuso MIURA, Reg. No. 09254

This man signed a declaration to the Custodian on March 25, 1942. He was evacuated on July 25, 1942.

In his declaration he reported 2 boxes of personal belongings at Dr. Uchida's, Powell Street, Vancouver, B. C. Nothing further appears on file about these, and it would appear that these were taken away by MIURA at the time of his evacuation.

He reported 7 boxes of goods stored at Duncan, Hillcrest. On May 18, 1942, he requested shipment of 3 boxes, 2 oil tins and a barrell. In the absence of evidence to the contrary, it is assumed that shipment was made as requested. The file of Mrs. Hana INOUE (File 9357) reveals the request made on April 7, 1943, for the shipment of a sewing machine for Mrs. Momoya MIURA, wife of Ryuso MIURA. Again, it is assumed that this shipment was made because there is no evidence that it was not. No further requests for any goods have been received from Ryuso MIURA, and it would appear that the seven articles requested were the 7 boxes he had declared, and that these have all been shipped to him.

He reported eleven \$5.00 War Savings Certificates in his own possession. These did not come under the control of this office.

This file reveals no other property of any kind.

M. Ebisuzaki filed a claim for \$5.00 against this man. MIURA denied owing this. P. S. Ross & Sons were so advised and no further action was taken by this office.

This file reveals no other assets or liabilities.
