Tacktocki declared in his JF Form, detect April 4, 1942, that he h d left his note and lines at Torra Nova Connery. He also declared a gas boat, dealt with in brown edged boat summary.

A statement dated June 5, 1922, from the Hunger of Imperial Cannery gives a list of note acreed as Indetecti KOYMAGI's. This list is similar enough to that of the Not Statement so that it need not be repeated here. KOYMAGI'S original but Indication appears under date of Narch 3, 1946, (it is filed directly behind the Not Statement).
