This file reveals the above owned no real property in any protected area of B.C., and did not carry any Fire Insurance.

CHATTELS:

The above, who made his declaration to the Custodien on April 3/42 and was evacuated on May 18/43, declared nets and fishing equipment and 1 row boat at the Terra Nova Cannery, Eburne, and personal property and living equipment at the Terra Nova Cannery.

On Feb. 5/43 we received from KOYANAGI a net form listing 7 nets. These have been seld as noted on the net statement of Jan. 29/44 for a total of \$305.00. Two nets, his numbers 3 and 7, were not found or inventoried by the Custodian.

On June 25/43 he sent us a Custodian release for a sewing machine stored in the house of K. SHIMONO at the Terra Nova Cannery. This was shipped to him on Oct. 8/43.

No other chattels were found at the Terra Nova Cannery marked with the name of the above, so we assume he disposed of his effects himself prior to his evacuation or took them with him.

On March 1/46 the account of the above was credited with the sum of \$10.00 being proceeds from sale of a row boat, now identified as belonging to the above, which had previously been credited to the account of Yukio KOYANAGI, File 847.
