## GENERAL SUMMARY

Yoshiye (Mrs. Tomizo) YAMANAKA.

This 32-year old Canadian-born Housewife from Ucluslet, B. C., signed a Custodian "JP" declaration form on the 2nd April, 1942. She was evacuated on the 24th September, 1942, and repatriated to Japan on the 2nd August, 1946.

Her husband, Tomizo, File 743, signed a Custodian "JP" declaration form on the 2nd April, 1942. He was evacuated on the 21st September, 1942, and repatriated to Japan on the 2nd August, 1946.

The following is a summary of the contents of this file as disclosed by a review made today.

Real Property: None.

Personal Property: The only item declared by this evacues was a Singer Sewing Machine "in transit via C.P.R. to Hastings Park", which was taken with her when evacuated to the Interior of British Columbia. On Sept. 15/42, this evacues signed a statement stating she had left no property of any kind whatsoever in the protected area.

Bills Receivable: None.

Bonds, Shares, etc.: None.

Bank Accounts: A balance of \$1,000.00 declared to be in Royal Bank of Canada, East End Branch, Vancouver, did not come under the administration of this office.
