This man signed a declaration to the Custodian on April 2, 1942. He was evacuated on April 21, 1942.

In his declaration he reported fishing net left at North Pacific Cannery, Vancouver. This was taken over by the cannery by arrangement with ISHIDA.

The records of the Japanese Fishing Vessels Disposal Committee show that this man was the owner of a boat "Ishida/M.I." This boat was sold and the net proceeds in the amount of \$232.65 was paid to ISHIDA on March 20, 1942.

This file reveals no other property of any kind.


