MEMORANDUM

TO: Mr. K.W. Wright

FROM: Miss H. Watkins

Re: P/W A-1330 - KOYANAGI, Iwao

I have checked through the above file, as well as Evacuee File No. 9112, which is the file of Isao KOYANAGI, and from the "JP" Forms and other information supplied in the files it does not appear that there is any connection between these two Japanese.

Iwao KOYANAGI formerly resided at 308 Heatley Avenue, which he states on his "JP" Form is owned by Isao KOYANAGI, to whom he paid \$9.00 per month. Apparently what brought up the question of any interest of Iwao KOYANAGI in the property described as Lots 1 and 2, Block 60, D.L. 181, was a Proof of Claim form received on April 30th, but I note that this also is made out in the name of Isao KOYANAGI and must have been placed on our file in error. The Tax Statement on our file is also made out to Isao KOYANAGI. The only instance where the name of Iwao is mentioned in connection with this property is on the Confirmation of Ownership, where his name is shown under the Name of Registrant, but this was following our memorandum to Mr. Macpherson, dated June 12th, in which we supplied the name. There is also a note on the bottom of the Confirmation of Ownership, which reads as follows:-

"On the records of the City Assessment Department this property is assessed to Isao Koyanagi, who holds it under an agreement of sale. Agreement is not registered".

Mr. Isao KOYANAGI claims to own this property on his "JP" Form and the Agreement for Sale, certified copy of which we received from the City of Vancouver on December 12th, 1942, is made out in his name. (This is the letter to Mr. Cramer, together with certified copy of agreement, referred to in the letter we received from the City of Vancouver, dated January 13th.) I cannot, therefore, see that there is any enemy interest in this property. I have placed the letter from the City of Vancouver in the Evacuee File No. 9112.

MEMORANDUM

A check of this file shows the following chattel transactions.

Iwao Koyanagi registered on April 2nd, 1942, at Hastings Park, declaring a number of household effects at 308 Heatley Avenue. 308 would doubtless be the number of the suite in 302-338 Heatley Avenue, Catalogue No. 74, now sold.

He was interned on April 21st, 1942, and on May 22nd we received from the Internment Camp a statement of assets and liabilities giving his belongings as "household fixtures, tools, clothings, \$1100.00".

Attached to the duplicate copy of the "JP" is an undated and unsigned statement headed "Japanese City Protection" and reading as follows. "Koyanagi has been evacuated to Blocan and sold all chattels before leaving. No need for storage here." This was doubtless the report of one of our City fieldmen.

On April 16th and June 3rd, 1943, Mr. Wright addressed a further enquiry to you to which you answered on June 7th that all chattels at this address were stored in a locked suite never opened by us but apparently containing effects belonging to many Japanese. A request was then addressed to the Internment Camp Commandant and was answered on June 15th by the Internee as follows.

"About the furniture, tools, clothing, sewing machine etc., I have no knowledge of their disposition but
