CHATELS:

The above, who made her declaration to the Custodian on April 4/42 and was evacuated on June 5/42, declared household effects left at House #35, Phoenix Cannery.

As no goods were found or removed from this house by our Steveston agent, we assume Mrs. MARUMOTO took all her effects with her when she was evacuated.

It is noted that a sewing machine was shipped to her daughter, Ichiko, File 7461, against a Custodian release dated Oct. 30/43. This machine was crated and labelled "I. MARUMOTO" and stored at 139 Garry St., Steveston. As this daughter declared having no property whatsoever, we must assume this was the sewing machine declared by the above.

The file reveals that the above owned no specified articles.

No property interests other than those mentioned above are found on this file.

The above summary is certified to be in accordance with the information on file.
