This man claimed ownership of the vessel "Miss Seymour", which was licensed in the name of Tokichi OZAKI (now known as Sankichi NOGAMI, Reg. 03557, File 1630).

Sankichi NOGAMI wrote on May 11, 1943, that he had passed the boat on to Shigeru, but there was no bill of sale and asked that the money be sent to him (Sankichi NOGAMI).

The proceeds of the sale have been credited to Sankichi NOGAMI, File 1630.

Re: Fishing Vessel "Miss Saviour". R.E. 84. V.087-2.

We are in receipt of your letter of the 11th instant, from which we note that you are the registered owner of the above vessel, which you had passed on to your son, Shigeru Hogami, without the formality of a Bill of Sale.

Our records show the registered owner of the boat to be Tokichi OZAKI, which we understand was formerly your name, but for the purpose of our records, we require documentary evidence of this, if correct. We would suggest, therefore, that you send us a properly completed affidavit briefly stating the facts regarding the two names. We will then be in a position to release the proceeds of sale of above vessel, which now stand at the credit of the account of Sankichi HOGAMI. These proceeds amount to:
