PERSONAL PROPERTY SUMMARY

This file reveals the above owned no real property in any protected area of B.C., and did not carry any fire insurance.

CHATELS: The above, who made his declaration to the Custodian on April 2/42 and was evacuated on Aug. 25/42, declared only a fishing vessel in custody of the R.C.M.P. at New Westminster. Nevertheless the file reveals that the above left three boxes of kitchen utensils at the North Pacific Cannery, Skeena River. He confirmed this on Oct. 16/42. These boxes were shipped to Vancouver on Jan. 31/44 by the Union Steamship Company and delivered to our warehouse at 992 Powell St. The contents were sold at Vancouver auction No. 11 for the net sum of \$1.22 and this amount was credited to the account of the above.

SPECIFIED ARTICLES: According to information supplied to this office the above was the registered owner of the fishing vessel the "TANEESE" which was sold through the Japanese Fishing Vessel Disposal Committee for the net sum of \$3,955.00, and this sum was paid to TANINO on June 16/42. Full details are given on Specified Articles Summary on file.

We have on file a copy of a letter written by the above dated June 25/45 to Mr. Ross Lord, Manager of the Phoenix Cannery, Steveston, asking him to ship the radio he had left in his care. Mr. Lord delivered this radio to us on July 10/45 and it was sold at auction for the net sum of \$7.51 and this sum credited to the account of the above.

WAR SAVINGS CERTIFICATES & SHARES: The above declared one \$5.00 War Savings Certificate in his own possession and ten shares in Intermountain Building and Loan Association. These securities did not come under the control of the Custodian.

BANK ACCOUNT: The above declared a savings account in the Royal Bank of Canada at Steveston in the sum of \$12.50. This was not brought under the control of the Custodian.

LIFE INSURANCE: The above declared a policy with the Sun Life Co., yearly premium being \$70.20, the beneficiary his wife Masue TANINO. This policy was not brought under the control of the Custodian.

No property interests other than those mentioned above are found on this file.
